2932 Rules and Procedures of Video Conferencing

Cllr Frank Bunce explained the rules and procedures of Zoom video conferencing to the Parish Councillors

2933 Clarification of Parish Council Meetings Held via Zoom Video Conferencing

The Clerk stated that the Coronavirus Regulations 2020 were passed by Government on 1st April 2020 and apply to meetings taking place before 7 May 2021.

The regulations enable local authorities to hold meetings remotely including by (but not limited to) telephone conferencing, video conferencing, live webcast, and live interactive streaming.

The RFO pointed out that as a result of these regulations, local authorities can determine not to hold their annual meeting and asked the Parish Council to agree on postponing its annual meeting until 2021.
