High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

BBV will be carrying out utility surveys on the northbound carriageway of the A446 between Chester Road and junction 4 of the M6, including the Junction itself. To carry out these surveys safely we will need to install a lane closure between 9pm on Tuesday 1 March until 5am the following morning.

The works also require the complete closure of the northbound slip road that connects the A446 with the A452 at the Northway Island -between 9pm on Tuesday 1 March until 5am the following morning.

When these works will take place

To carry out these works safely, we will close the slip road and one lane of the northbound carriageway over night.

Works are scheduled to begin at 9pm on Tuesday 1 March until 5am on 2 March. These works are subject to weather conditions.

Traffic wishing to exit the Northway Island onto the A446 will be diverted south towards the Stonebridge Island and back up to the A446 Junction near Melbicks Garden Centre.

- Increase in journey time when following diversion.

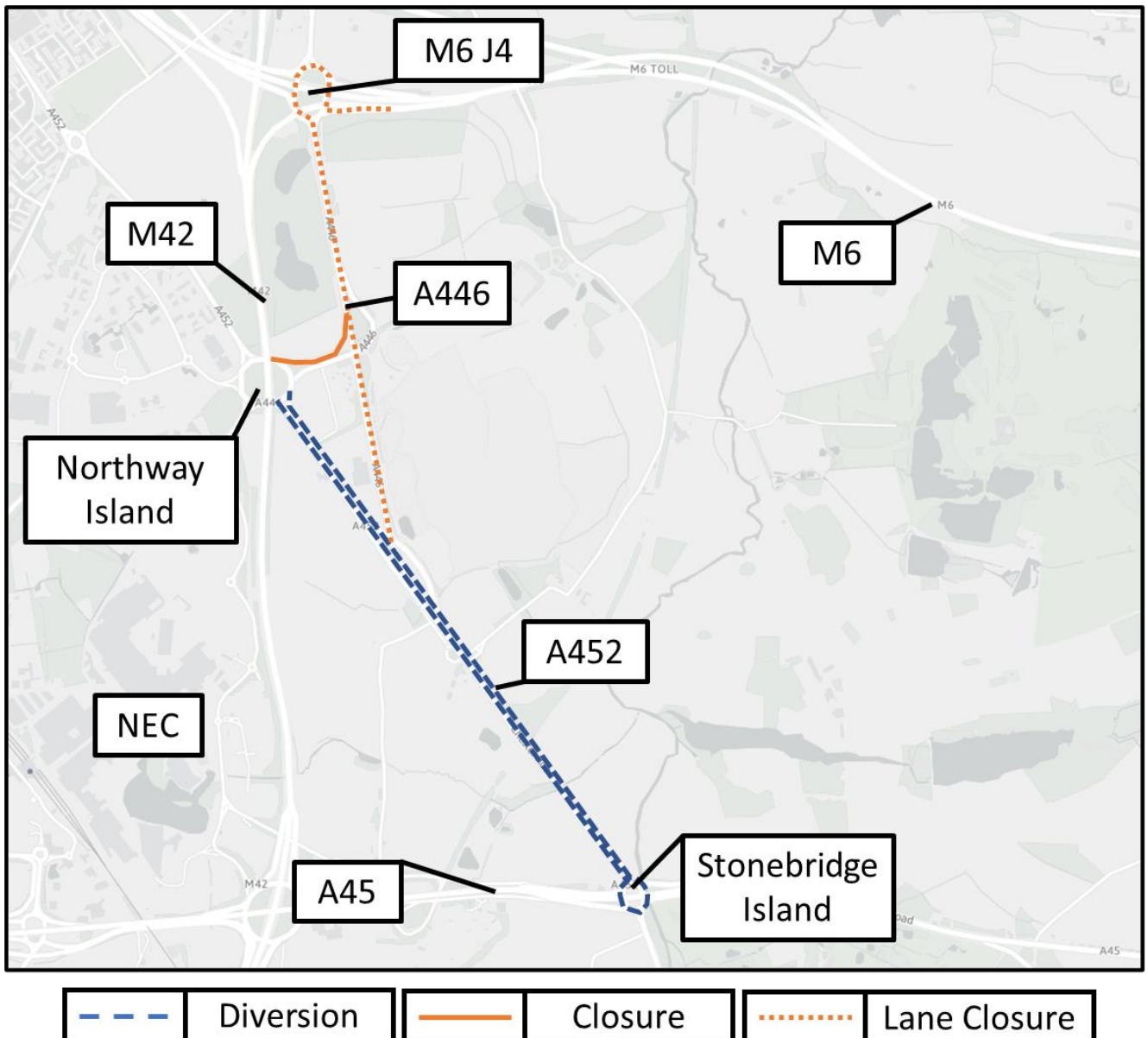
