High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

BBV will be carrying out utility surveys on the M6 junction 4 and the A446 **When these works will take place**

To carry out these works safely, we will fully close the northbound slip road leading to the junction and close a southbound lane on the A446.

Northbound traffic wishing to exit the M6 at junction 4 will be diverted south via the M42 then on to the A45 at Junction 6 of the M42, then north via the A452 at the Stonebridge Island.

Works are scheduled to begin from Wednesday 2 March until Friday 4 March and will be in place between the hours of 9pm and 5am. These works are subject to weather conditions.

- Increase in journey time when following diversion.


