



# Notice of Lane Closure on A452 Kenilworth Road - Hampton-in-Arden

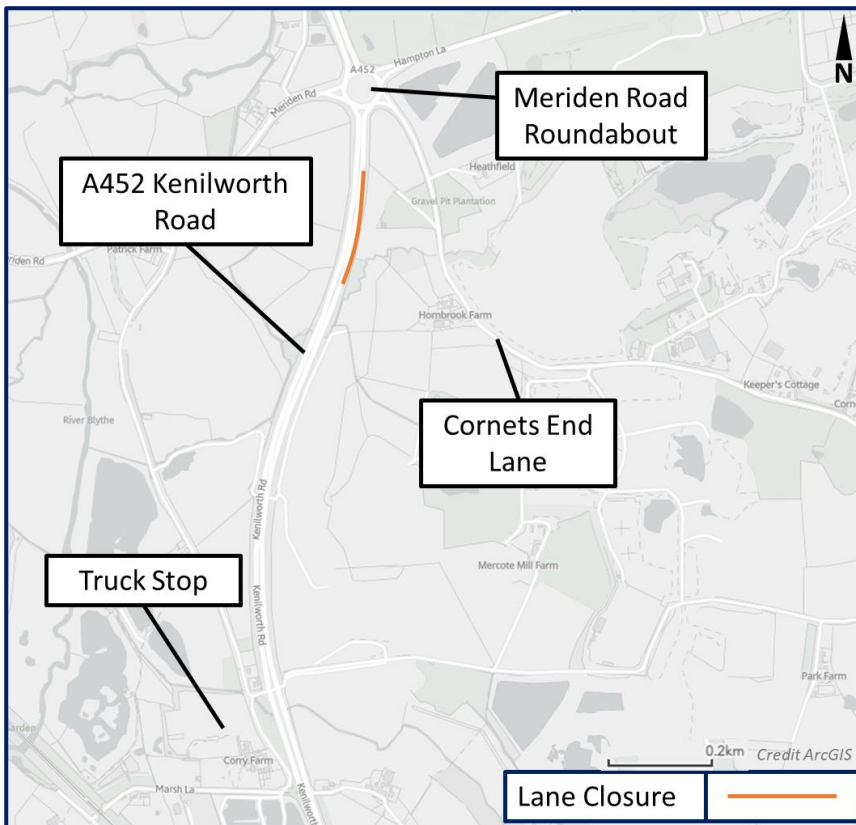

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing.

The new railway will pass under a newly realigned A452 between the Meriden Road Roundabout and Lincoln Farm truck stop. The new alignment will tie back into the existing road just south of Meriden Road roundabout. In order to prepare for this work, we will need to undertake some vegetation clearance. To do this work safely we will need to cone off lane one of the southbound A452 for 2 weeks from 11 April until 14 April. The closure will be in place 8am-6pm Monday to Friday.
