

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

#### The work we will be doing

The new railway will be elevated on an embankment as it passes over Coleshill Heath Road. To ensure that our work does not affect the supply, a number of utilities will need to be diverted. In order to do this, a one-way system will be in operation from 3 April 2023 until 19 May 2023. Traffic heading southwest towards Chelmsley Wood will be able to travel down Coleshill Heath Road at a reduced speed limit of 30mph. Traffic heading northeast towards Coleshill will be diverted via Chester Road, over the motorways on Birmingham Road then south via Stonebridge Road towards Junction 4 of the M6. (See map below) These restrictions will be in place all day every day. Pedestrian access will be maintained.
