

MARSTON GREEN BURIAL GROUND FEES 2025/2026

Fees, Payments and sums fixed and settled under Article 15 of the Local Authorities Cemeteries Order 1977 and Section 9 of the Cremation Act 1902 BY Bickenhill & Marston Green Parish Council acting as Burial Authority for the area.

The fees set out below apply when a person is to be interred who, immediately before death, was an inhabitant of the civil parish of Bickenhill & Marston Green. In other cases, fees will be those listed as out of area non-resident fees. Please note, from 1 April 2023 the Parish Council have limited the sale of grave and ashes plots to residents of the Parish only.

Please also note that invoices are due for payment on receipt. Cleared funds are required before any application is processed by the Parish Council.

Resident Fees

Part	t 1: Exclusive Right of Burial Resident	
The	Exclusive Right of Burial is valid for a period of 75 years from the date of purchase.

c)	Of cremated remain	£310.00	

Out of Area Non-Resident Fees

These are the fees which apply to people living outside the Parish of Bickenhill & Marston Green or to former residents who lived outside of the Parish immediately before their passing.

a)	Burial Plot for one or two coffins in a grave space approximately 8ft x 4ft	N/A
b)	Ashes Plot for one/two cremated remains in a plot approximately 18" x 24"	N/A

a)	For the body of a still born child or the body of a child whose age at the time of death did not exceed twelve years	£0.00

The following fees apply for the Right to Erect or place on a Grave/Ashes Plot, Memorial, Headstones, Tablets and Memorial Inscriptions.

b)	Tablet for an Ashes Plot not exceeding 16" x 12" (landscape)	£127.00
c)	Tablet for a Double Ashes Plot not exceeding Size: 32" x 12" (landscape)	£254.00
d)	Additional inscription to Headstone or Tablet	£92.00
е)	Carry out the Refurbishment of a headstone/tablet	£0.00
